

# A Letter to My Great-Great Grandchildren

Recently, I finished reading a book related to fundraising. Actually, it focused on planned giving, but the conclusion was that we have much more to offer our children, grandchildren and beneficiaries than money, no matter how much we have or don't have: each attitude, each, value, each virtue, and each flaw gets passed on to those who know us and those who follow us. The authors of this book, titled Breaking the Midas Curse, asked this question on the cover: "Why does hard work and financial success lead to disaster for so many families, and how can you save yours?" They asked a question that I could not answer: they asked their readers to tell all they know about their great-great grandparents. In a word, my answer was "nothing!" Actually, I, like everyone else, would have 16 great-great grandparents. I know nothing about any of them; they would have lived

between 150 and 200 years ago.

Be that as it may, and I am sure that I inherited characteristics from each of these 16 individuals, these two authors—Perry Cochell and Rodney Zeeb—made a more helpful but equally challenging suggestion: they recommended that each of us write a letter to our great-great grandchildren.

We can all do this. We should all do this.

They won't be around for another 150 or 200 years, but they will still be made of skin and bones, they will still be affected by their environment, and wonder of wonder, they will carry lots of genes in their jeans that are the result of who we are and what we believe today.

In one of my sleepless periods recently, I decided to write this letter. If I wrote it again, and I probably will, it would be different, but here is my attempt to cross into an uncertain future for some special people who will be my offspring (and, if each of my six children have two chil-

dren, each of these 12 grandchildren have two children, and each of their 24 children have two children, I am writing to some 200 individuals, counting spouses, in the late 22<sup>nd</sup> Century...):

If someone asked me "What are the most important truths I could pass along to others in the future, what would they be?" Here they are:

- When you disagree with someone, try not to be disagreeable.
- Get all of the education you can get; education and character are permanent possessions.
- Reputation and recognized success are very important, but they are not nearly as valuable as character, integrity, and vision.
- Learn to be a giver, by giving time, talent, money; give requested advice and a listening ear.
- A little impatience is not a bad thing. A life not fully lived is a life wasted.

- The choice of a spouse is impossible to overemphasize; don't fail in this decision.
- Don't plan to fail, but realize that you sometimes will; and don't fail to plan or you will fail much more often.
- Say "thank you" much more often and sincerely than other people do or than anyone expects.
- Be kind to everyone, including strangers.
- Read voraciously....books, magazines, newspapers, directions, signs, everything. I recommend that you "read your age" for a lifetime (e.g., read 20 books per year at age 20, 40 at age 40, etc.).
- Reading fiction is not always harmful, but reading only fiction distorts life. Do read biographies of great people, study the religions of the world, seek truth and inspiration and embrace the concept of self-help.
- Plan to grow because of the books you read, the friendships you cultivate, and all of the hours you work without compensation. You often "earn" more during volunteer hours than during hours doing the job for which you are paid.
- Find your own guidelines for living. Here are some that I suggest:

The Golden Rule: "Do unto others as you would have others do unto you"

The motto of Rotary International: Service Above Self

The Rotary Four Way Test:

Is it the Truth?

Is it Fair to All Concerned?

Will it Build Goodwill and Better Friendship?

Will it Be Beneficial to All Concerned?

- Travel. Go as many places as possible, as often as possible, with a notebook, camera and an open mind.
- Invest in something bigger than your dreams (whether it is a service club project, a program focused on children, animal welfare, health, culture or the redemption of man). Be open to gigantic possibilities, but remember:

The way to eat an elephant is one bite at a time; The way to live a life is one day at a time; The way to help others is one person at a time.

So much for my letter to my far-in-the-future Davis great-great grandkids. I have sent these suggestions to my six kids and they may well be lost before my grandkids ever see them, much less my great-great grandkids. In any event, we are players in a long-running mystery called life and we need to get as much out of it as we can. More importantly, we should try to leave more than we had when we started.

One of the really great Americans was Will Rogers, a cowboy humorist from Oklahoma. One of his most quoted statements was made at Boston's Tremont Temple Baptist Church on June 16, 1930:

"When I die, my epitaph, or whatever you call those signs on gravestones, is going to read 'I joked about every prominent man of my time but I never met a man I didn't like.' I am so proud of that. I can hardly wait to see it carved. And when you come around to my grave, you'll probably find me sitting there proudly reading it."

When push comes to shove, there is no better guideline yet invented than The Four Way Test for measuring our thoughts, words and deeds, whether it is spiritual, social, political, economic, socio-psychological, physical or uplifting for youth, these four questions can and should serve as guidelines for self-measurement in terms of what we believe, what we say, what we do and who we are:

Is it the Truth?

Is it Fair to All Concerned?

Will it Build Goodwill and Better Friendship?

Will it Be Beneficial to All Concerned?

In conclusion, we are to live as if everyone is watching and to leave a legacy that goes down to our kids, grandkids, great-grandkids and beyond.
