**November is Rotary Foundation Month!** The Foundation is a not-for-profit corporation supported solely by voluntary contributions from Rotarians and friends of the Foundation. The mission of the Rotary Foundation is to enable Rotarians to advance world understanding, goodwill, and peace through the improvement of health, the support of education, and the alleviation of poverty.

In 1917, RI President Arch C. Klumph proposed that an endowment be set up "for the purpose of doing good in the world." In 1928, when the endowment fund had grown to more than US\$5,000, it was renamed The Rotary Foundation, and it became a distinct entity within Rotary International. Since the first donation of \$26.50 in 1917, it has received contributions totaling more than \$1 billion. To date, more than one million individuals have been recognized as Paul Harris Fellows—people who have given \$1,000 to the Annual Programs Fund or have had that amount contributed in their name.

Programs include: PolioPlus, Humanitarian Grants Program (Disaster Recovery; District Simplified Grants; Health, Hunger, and Humanity (3-H) Grants); Matching Grants; and Volunteer Service Grants.

Education Programs include: Ambassadorial Scholarships; Group Study Exchange (GSE); Rotary Grants for University Teachers; The Rotary Peace and Conflict Studies Program,; and Rotary World Peace Fellowships.

Humanitarian grants from The Rotary Foundation enable Rotarians to increase their support of international service. Contributions to Rotary Foundation funds enable Rotarians to carry out humanitarian and educational projects. Donors may direct their gifts to three main funds: The Annual Programs Fund, which supports the foundation's humanitarian, educational, and cultural exchange programs worldwide; The Permanent Fund, which provides an endowment; and The PolioPlus Fund.

The GSE program allows young professionals to visit another country and learn about their vocations and cultures in the host country. The visits last about four weeks are filled with many educational, vocational, social, and cultural opportunities. Team members are housed with host families which allows for the development of many friendships.

Claudia is the Operations Coordinator for the New Mexico Health Insurance Alliance, a non-profit third-party administrator for health insurance plans. While in Brazil, Claudia hopes to learn more about the national healthcare system. The insurance is available to everyone and she would like learn more about access to health care through the government system as well as the private insurances that are available to people who can afford the premiums. Claudia is looking forward to learning about the advantages and disadvantages of the universal health care system in Brazil which has been in place for more than 10 years.

Claudia was born in Santiago, Chile and became a U.S. citizen in March 2007. She has a three year old son, Thane. She studied Portuguese at the Brazilian embassy in Santiago. Claudia is currently brushing up on her Portuguese, along with other GSE team members, by taking a private class. In addition to speaking lots of Portuguese while in Brazil, Claudia hopes to indulge in a little singing and dancing as well!
